WATER RESOURCES COORDINATOR REPORT

A copy of the Cease & Desist Letters developed by Attorney Blankenau regarding non-compliance to the Phase II Crop Reporting Form and the Flow Meter requirements were available in the packets. Jim also mentioned they are in the process of learning their new Conservation Desk Top Program.

NC RC&D—Connell mentioned the paper shredding along Highway 12 was held. They are planning on an Electronic Recycling collection next month and a Tire Recycling collection in September. Middle Niobrara NRD has agreed to work with the RC&D to find a site for the Tire Recycling collection.

A copy of Conner's January Report along with Jeremy Milander's January Report and the Minutes of the February 4th Bazile GWMA Meeting were mailed to Directors. Conner reported he has been working on paying producers their cost share and meeting with them to sign up for EQIP. The Cover Crop Workshop held in Norfolk was well attended with 145 attendees. He has participated in the zoom meetings for the Communication Group which is trying to get Community involvement in reducing nitrates. There was a producer meeting in Creighton with 12 attending with another being planned in March. An application was submitted for the Bazile GWMA to become a member to the Groundwater Guardian Program. Two graduate students will be hired using the NET Grant. Plans are to hire a couple of students to help with summer field work.
