MANAGER'S REPORT

A copy of the Manager's Report was mailed to the Directors prior to the meeting for their review. Connell questioned the Mediation Fee. Liewer explained he was instrumental in requesting this. The Niobrara River Basin Caucus to be held on January 15th at 11:00 A.M. in the Middle Niobrara NRD Office. Staff will be leaving the office at 9:00 A.M. Any Director wishing to attend should contact the office to pool rides. Greg Wilke indicated he would be willing to continue to serve on the Natural Resources Commission Board representing the Niobrara Basin. Discussion was held on the new NRCS Service Boundaries. Jim Mathine explained in the past the O'Neill DC supervised the Ainsworth Office. Changes have been made on service boundaries and now the Ainsworth Office will be supervised by the Valentine DC. A copy of the map and additional information was in the report Jim mailed to the Directors. Copies of the Bazile GWMA reports and minutes were in the packets. A copy of the Forester, Pam Bergstrom's report was also in the Director packets.

WATER RESOURCES COORDINATOR REPORT

Wade's report was mailed prior to the meeting for Directors to review. He informed the Board the monitoring well bids are due tomorrow. If no bids are received will have to try to negotiate with the well drillers. He reported there were an additional 211 Phase II reports received today in addition to the 561 that were submitted by December 22nd. There are over half of the 180 Flowmeter Reports received so far. He drew attention to the reverse side of his report which showed the applicants of high-capacity wells for 2020. 5 of the wells have already been drilled for the newly approved irrigated acres.

Wade explained the Variance Committee met prior to the meeting to review the Ernest Hallock request. Ernest applied for 35 acres on newly rented ground and 25 acres of his own. Motion by Klawitter and second by Kaczor to deny the Ernest Hallock Variance Request as the deadline for new irrigated acres has passed and the water source is not on these acres. PROGRAMS ASSISTANT REPORT

Connie's report was also mailed to the Directors prior to the meeting. She mentioned the new website is online now. The Water Warriors Meeting will be virtual on February 3rd, 10th, 17th and 24th. These meetings will qualify for Nitrate Certification with certain criteria at the log in. Nitrogen Certification Dates are: Upper Elkhorn on February 16th & 17th, Lewis & Clark-February 23rd & 24th, LNNRD-February 22nd. The Bazile GWMA now has a website online.

ASSOCIATION REPORT

Resolution—A copy of the Resolution to be signed by the NRD was mailed. Liewer explained the NARD's search for an office building. There were two options for payment of the building: (1) bill the NRD's and (2) borrow excess funds from the NARD Risk Pool Insurance Fund. A transfer of these funds to the NARD Foundation was approved by the NE Dept of Insurance. In October the sales agreement for the new building was signed. In December it was decided at the suggestion of the Department of Insurance to issue dividends to the NARD Foundation as a better way of tracking the transferred funds. The \$900,000 will be divided equally among the 23 NRDS who in turn will return it to the NARD thus the need for the Resolution. The long-term goal is to repay the NARD Risk Pool Fund. Motion by Liewer and second by Randa to approve signing the Resolution of the Board of Directors of the Lower Niobrara Natural Resources District regarding the purchase of the NARD Office Building utilizing Risk Pool Funds. It was asked who would be attending as the NARD is requesting a tentative number. No directors indicated they planned to attend. Liewer volunteered to serve as the Voting Delegate if there would be a zoom meeting. He indicated he would not attend in person due to COVID.

NRCS—Jim Mathine mailed his report to the Directors. Jim mentioned the service area and change of supervision for the Ainsworth Office was discussed earlier. Craig Derickson retired in December after serving as the State Conservationist for Nebraska for 10 years. He was a native of O'Neill. Hopefully in March/April EQIP funds can be allocated as they are currently working on ranking the applications. The CRP signup period runs thru February 12th.

<u>Niobrara Council</u>—Connell reported the meeting was held on December 12th and a copy of the minutes was in the packets. He mentioned the Governor will be making the appointment regarding the open positions on the Council. The NPS gave an update. The NGPC discussed the presence of Mountain Lions in the area and Wolves were also discussed. The Forest Fuels Reduction Project was discussed.

NE RC&D—Pavlik reported the next meeting will be at the end of January.
