Nitrate levels have continued to climb to the excess of 200 + parts per million. NDEE has submitted well samples to the state for isotope testing, we are currently awaiting those results. McCarthy has tested surrounding wells and scheduled a talk and test in the Lynch area. She has wrapped up tree ordering for the year. She stated she ordered 9000 trees with 14 tree plans from the NRCS in Spencer.
